Human Resource Management (HRM) encompasses a vast swath of the Business Services sector, but it is best described as the business of workforce management. Traditional segments in the HRM industry are Temporary Staffing, Job Recruitment and Outsourced Services. In this report, we have broken down the traditional sectors to a more defined set of categories: Commercial Staffing, Consulting, Government IT Staffing, Healthcare Staffing, HR SaaS, IT Consulting & Staffing, Management Consulting and Professional Staffing.

Workforces expand and contract with economic performance, productivity gains, and changes in the application of technology. We present macro-economic data and workforce related costs as a backdrop to the expansion or contraction of the many segments of HRM.

Most importantly, we address valuation trends for companies in each segment over multiple years to provide some historical context to value growth and contraction and to provide valuation insight to potential sellers and buyers of businesses in each sector.

Finally, we address the current M&A transaction activity for the most recent period and provide comparisons to relevant prior periods.

2021 M&A Overview and Outlook

Business and consumer confidence remains high through June 30 surveys, but the spread of the Delta variant of the COVID-19 virus has some concerned about the near term. As we write, August reports of retail sales and homebuilder sentiment for July missed expectations.

The American Staffing Association (ASA) Staffing Index finished the quarter at 97, a new high-water mark for 2021, but on par with the same pre-pandemic periods in 2019 and 2018. This index is considered by many to be a good leading economic indicator.

Job openings continue to rise and, at 10.1 million, have set another new high. Job Quits remain very high at 3.9 million. The Labor Force Indicators clearly show this historical misalignment, (see table later in this report). The labor force participation rate has risen from a low of 60.2% during the height of the pandemic to 61.7% as of July, still below the recent historical average of 63% in the three years preceding the pandemic.

Wage growth is very high with the Department of Labor (DOL) in July reporting a 4.8% increase on a 24-month annualized basis vs. 3.3% increase on the same basis for January 2020. There are additional incentives for workers in the form of benefits and signing bonuses to entice them back to work or to change jobs.

While the above information generally bodes well for employment growth, inflationary pressures are suppressing net gains for lower wage workers. The Consumer Price Index

It is yet to be seen if these inflationary pressures are indeed transitory as the Federal Reserve Board and others believe, or if they are here to stay, which will place a burden on sales and earnings for some industries and workers.

M&A multiples remain high, especially compared to the same period one year ago, during the height of the pandemic. Public company multiples across the HRM spectrum settled to a mean of 12.9x at the end of the quarter, slightly below the mean of 13.5x at the end of the 1st quarter.

GDP continued to grow at an annualized rate of 6.5% in Q2 following 6.3% growth in Q1. The Conference Board Projects GPD will rise to 7.0% in Q3 and end up at 6% year over year.

M&A Outlook Key Drivers

Current key drivers we have identified as most responsible for the boost in M&A activity.

- Abundant supply of seller targets seeking to de-risk: distressed/tired, retirement/early retirement, smaller firms looking for stability, larger firms looking for transformative deals and, as always, opportunistic sellers.
- Broad based buyers seeking opportunities: existing platforms need to scale, PE's need to put money to work in new platform investments, strategics need to increase market share, wealthy industry investors want a repeat.
- Renewed economic optimism among consumers, as well as business leaders.
- Increasing capital gains tax will play a role in valuations – less favorable seller terms to gain higher EV – more risk on the back end for sellers.
- Historically low interest rates with US 10-year Treasury Notes yielding just 1.347%.

- Historically high liquidity (money supply M2) for market participants resulting from central bank "easy money" policies.
- The effects of previous fiscal stimulus continues to support growth and activity in the market and we anticipate additional fiscal stimulus from various broadly defined infrastructure initiatives will continue to fuel growth in revenues and consolidation in various industry sectors.
- Significant reservoirs of investment capital seeking returns across venture capital, private equity and public equity markets (including recently minted SPAC vehicles).
- Record economic growth in Q1 and Q2 2021 and continued record growth expected in Q3 based upon snap back recovery, pent up demand and artificially low year ago fundamentals due to the pandemic.
- Historically high multiples on public equity market valuation multiples as relative comps for private transactions.


Labor Force Indicators

- Job Openings for June climbed to another record, reaching 10.1 million, which is an increase of 590,000.
- Hires jumped significantly in June increasing by 697 thousand to 6.2 million, the highest since May of 2020.
- Quits for June reached 3.9 million the second highest since last April.

- The unemployment rate for July decreased to the lowest value since the start of the pandemic to 5.4% from June's 5.9%.
- The Quits Rate for June came in at 2.7%.

HRM 2021 Q2 vs. 2021 Q1 Transactions

M&A activity in Q2 included 136 transactions, lower than what we saw in Q1 with 159, but perfectly in line with historic seasonality. For comparison Q2 vs. Q1 in 2019 experienced 96 vs. 107 transactions and Q2 vs. Q1 in 2020 saw 76 vs. 102 transactions. IT Consulting and Staffing still accounted for 57% of the deals in Q2, logging 78 reported transactions vs. 85 in the first quarter.

Commercial Staffing accounted for the biggest increase over the preceding quarter with 4 more deals followed by Healthcare Staffing, Professional Staffing and HR related SaaS with one more deal each. Government IT Staffing & Consulting experienced 5 fewer deals, IT Consulting and Staffing saw 7 fewer deals, and Management Consulting saw 11 fewer deals than in the preceding quarter.



HRM 2021 H1 vs. 2020 H1 Transactions


Comparing H1 2021 to H1 2020 we see a huge transaction increase of 65% or 117 additional deals. In total the first half of 2021 has seen a total of 295 transactions versus 178 in 2020. IT Consulting & Staffing leads the deal surge with 57 more transactions, followed by Healthcare Staffing with 16 more deals, Professional Staffing with 12, Outsourcing Services with 10, Government IT Staffing & Consulting added 9, Commercial Staffing with 6, Management Consulting with 4, and lastly HR SaaS with 3 more transactions.






