## **The Report**

Human Resource Management (HRM) encompasses a vast swath of the Business Services sector, but it is best described as the business of workforce management. Traditional segments in the HRM industry are Temporary Staffing, Job Recruitment and Outsourced Services. In this report, we have broken down the traditional sectors to a more defined set of categories: Commercial Staffing, Consulting, Government IT Staffing, Healthcare Staffing, HR SaaS, IT Consulting & Staffing, Management Consulting and Professional Staffing.

Workforces expand and contract with economic performance, productivity gains, and changes in the application of technology. We present macro-economic data and workforce related costs as a backdrop to the expansion or contraction of the many segments of HRM.

Most importantly, we address valuation trends for companies in each segment over multiple years to provide some historical context to value growth and contraction and to provide valuation insight to potential sellers and buyers of businesses in each sector.

Finally, we address the current M&A transaction activity for the most recent period and provide comparisons to relevant prior periods.




## **Economic Condition and Outlook**

The American Staffing Association (ASA) Index, which tracks weekly changes in temporary and contract employment, decreased slightly to 102 after rising to its highest value in more than 15 years of 108 in November '22.

Public valuation multiples are subdued and continue fluctuating. Public company EV/EBITDA valuation multiples across the HRM spectrum have recovered to 9.5x in Q4'22 versus 8.8x one guarter ago. One year ago, the multiple was observed at 12.0x.


Consumer confidence decreased moderately to 107.1 in January from 109.0 in December and holds well above its 2022 low of 95.7 seen in July. The Present Situation Index, based on consumers' assessment of current business and labor market conditions, increased to 150.9 in January from 147.4 in December. The Expectations Index, based on consumers' short-term outlook for income, business, and labor market conditions, declined to 77.8 in January from 83.4 in December.



US real gross domestic product grew at an annualized rate of 2.9% according to the advance Q4'22 estimate, following a growth of 3.2% in Q3'22, the US Bureau of Economic Analysis reported.

The GDP outlook according to the consensus in the Federal Reserve's forecaster survey has been revised upward from the prior forecast surveys to 0.6% for the first guarter and 1.0% for the second guarter, up from 0.2% for each guarter in the last survey. For the annual 2023 GDP on the other hand the forecast was upgraded to 1.3% from 0.7%.


As far as the forecasters survey on the unemployment situation is concerned the rate is expected to increase from 3.5% in the first quarter to 4.4% in the fourth quarter. This is a downward revision from the previous forecast which expected a rise of unemployment from 3.8% to 4.4% over the same period.

### **Labor Force Indicators**

- Job openings for December '22 increased to 11.0 million compared to 10.4 million the month prior, remaining at historically high levels yet slightly below the level a year earlier.
- At 6.2 million, Hires too increased, but were lower than a year ago. However, the level of Hires still stands elevated compared to prepandemic times.
- The Quits level is slightly down from November with 4.1 million, which is significantly lower than in December a year ago with 4.4 million yet remains significantly above the prepandemic levels.
- The unemployment rate in January surprisingly eased downward to a historic low of 3.4%, after decreasing to 3.5% in December and 3.6% in November. The last time the unemployment rate reached a level this low was in May of 1969.
- The Quits rate remains relatively stable at 2.7% after briefly dipping to 2.6% back in October.

## HRM 2022 Q4 vs. 2022 Q3 Transactions

The last quarter of 2022 saw 132 M&A transactions, a slightly higher volume than in Q3 with 130 transactions, yet lower than the 151 transaction in Q4 of 2021.

IT Consulting and Staffing led Q4 deal activity accounting for 52% of deals, or 69 transactions. This marks an 8 deal decrease over Q3. Management Consulting deal volume experienced 2 fewer deals over Q3.


Increases in transaction volume over Q3 were observed in Professional Staffing with a 5 deal increase (14 in total), Commercial Staffing with a 3 deal increase followed by Government IT Staffing & Consulting, Healthcare Staffing, Outsourcing Services and HR SaaS each with one additional deal.

## HRM 2022 vs. 2021 Transactions

Comparing total 2022 transaction counts, transactions totals ended up lower than in 2021 by 67 deals. In total we have experienced 516 transactions vs. 583 transactions in 2021.

Two segments have seen deal increases over 2021 which are Professional Staffing with 14 additional deals and Management Consulting with 10 additional deals.


Decreases were observed in Commercial Staffing with 2 fewer deals, Outsourcing Services with 6 fewer deals, HR SaaS with 7 fewer, Government Staffing & Consulting with 12 fewer deals, Healthcare Staffing with 15 fewer deals, and IT Staffing & Consulting with 49 fewer deals.




