### **The Report**

Human Resource Management (HRM) encompasses a vast swath of the Business Services sector, but it is best described as the business of workforce management. Traditional segments in the HRM industry are Temporary Staffing, Job Recruitment and Outsourced Services. In this report, we have broken down the traditional sectors to a more defined set of categories: Commercial Staffing, Consulting, Government IT Staffing, Healthcare Staffing, HR SaaS, IT Consulting & Staffing, Management Consulting and Professional Staffing.

Workforces expand and contract with economic performance, productivity gains, and changes in the application of technology. We present macro-economic data as a backdrop to the expansion or contraction of the many segments of HRM.

Most importantly, we address valuation trends for companies in each segment over multiple years to provide some historical context to value growth and contraction and to provide valuation insight to potential sellers and buyers of businesses in each sector.

Finally, we address the current M&A transaction activity for the most recent period and provide comparisons to relevant prior periods.

### **Economic Condition and Outlook**

The American Staffing Association (ASA) Index tracks weekly changes in temporary and contract employment and stands at 89, 8.5% below year ago levels and constant with the prior quarter ending December.

Public valuation multiples are 5.6% above year ago levels with a mean EV/EBITDA multiple across all segments at 10.4x versus 9.8x a year ago. The increase in multiples was observed across all segments except in Management Consulting and Healthcare Staffing. The multiple was also sequentially higher than the December 2023 level of 10.1x.

The Consumer Confidence Index decreased in April for the third consecutive month to 97.0, down from 103.1 in March. The Present Situation Index, based on consumers' assessment of current business and labor market conditions, declined to 142.9 in April from 146.8 a month earlier. The Expectations Index, based on consumers' short-term outlook for income, business, and labor market conditions, deteriorated to 66.4 in April, down from 74.0 in March.

US real gross domestic product grew at a slightly lower-thanexpected annualized rate of 1.6% according to the advance Q1'24 estimate, following a growth of 3.4% in Q4'23, the US Bureau of Economic Analysis reported.

The GDP outlook according to the consensus in the Federal Reserve's forecaster survey was revised upward from the prior forecast of 1.5% to 2.1% for Q2'24.

The forecasters further expect whole year GDP for 2024 to grow at 2.5%, up 0.1 percentage points compared to the previous survey.

The survey prediction on unemployment remained unchanged from the prior forecast with the expected unemployment rate of 3.9% in Q2'24 growing to 4.0% by Q4'24.



### **Labor Force Indicators**

- Job openings decreased from 8.8 million in February to 8.5 million in March and remains 0.4 million below the level in December of 2023.
- Job hires is down slightly from 5.8 million in February to 5.5 million in March and remains 0.3 million below the level in December of 2023. The number of hires is now slightly below the levels seen just prior to the pandemic.
- March Quits level decreased to 3.3 million marking a return to levels seen in 2018 during stable economic conditions.
- The March Quits rate decreased to 2.1% after hovering at 2.2% in the four months prior.
- April's unemployment rate inched back up to 3.9%, after decreasing to 3.8% in March. Unemployment is also up from 3.7% in December.

### HRM 2024 Q1 vs. 2023 Q4 Transactions

Q1'24 registered fewer M&A transactions at 79 deals compared to 98 transactions in Q4'23.

IT Consulting and Staffing led Q3 deal activity accounting for 39% of deals, or 31 transactions. This marks an 8 deal decrease over Q4 for the most active segment. Government IT Consulting & Staffing, the second most active segment with 15% of deals, experienced 12 transactions, 2 less than in Q4.


Increases in transaction volume over Q4 were observed in Outsourcing Services with 3 more deals and HR SaaS with 1 additional deal. Commercial Staffing and Management Consulting stand unchanged in deal count. Professional Staffing had 6 fewer transactions while Healthcare Staffing experienced no deals in the quarter.

### HRM 2024 Q1 vs. 2023 Q1 Transactions

Comparing total Q1 transaction counts to twelve months ago, transaction totals ended up lower by 24 deals. In total we have experienced 79 transactions this quarter vs. 103 transactions in Q1'23.

Government IT Consulting & Staffing experienced a 7 deal increases, followed by Outsourcing Services with 4 more deals, and Commercial Staffing with 1 additional transaction. HR SaaS stayed unchanged.


Decreases were observed in IT Consulting & Staffing with 29 fewer deals, Professional Staffing with 3 fewer deals and Management Consulting with 1 fewer deals. Healthcare Staffing experienced no transactions in Q1 versus 3 transaction in the first quarter a year ago.












