Human Resource Management (HRM) encompasses a vast swath of the Business Services sector, but it is best described as the business of workforce management. Traditional segments in the HRM industry are Temporary Staffing, Job Recruitment and Outsourced Services. In this report, we have broken down the traditional sectors to a more defined set of categories: Commercial Staffing, Consulting, Government IT Staffing, Healthcare Staffing, HR SaaS, IT Consulting & Staffing, Management Consulting and Professional Staffing.

Workforces expand and contract with economic performance, productivity gains, and changes in the application of technology. We present macro-economic data and workforce related costs as a backdrop to the expansion or contraction of the many segments of HRM.

Most importantly, we address valuation trends for companies in each segment over multiple years to provide some historical context to value growth and contraction and to provide valuation insight to potential sellers and buyers of businesses in each sector.

Finally, we address the current M&A transaction activity for the most recent period and provide comparisons to relevant prior periods.

Economic Condition and Outlook

The American Staffing Association (ASA) Index which tracks weekly changes in temporary and contract employment stands at 90, 10.0% below year ago levels and two points above the prior quarter ending June.

Public valuation multiples are 8.9% above year ago levels with a mean EV/EBITDA multiple across all segments at 10.5x versus 9.6x a year ago. The increase in multiples was observed across all segments except in HRM SaaS. Compared to the end of Q2'24, the composite multiple increased slightly from 10.4x to 10.5x.

The Consumer Confidence Index increased in October to 108.7, up from 99.2 in September. The Present Situation Index, based on consumers' assessment of current business and labor market conditions, increased to 138.0 in October from 123.8 a month earlier. The Expectations Index, based on consumers' short-term outlook for income, business, and labor market conditions, increased to 89.1 in October, up from 82.8 in September.


US real gross domestic product grew at a higher-than-expected annualized rate of 2.8% according to the advance Q3'24 estimate, following growth of 3.0% in Q2'24, the US Bureau of Economic Analysis reported.

The GDP outlook according to the consensus in the Federal Reserve's forecaster survey was revised upward from the prior forecast of 1.7% to 2.2% for Q4'24. Q1'25 GDP growth is expected to be 1.9%.

The forecasters further expect whole year GDP for 2024 to grow at 2.7%, up 0.1 percentage points compared to the previous survey.

The survey prediction on unemployment was raised from the prior forecast with the expected unemployment rate of 4.2% in Q4'24 and remaining at that level throughout Q1'25.





Labor Force Indicators

- Job openings decreased from 7.86 million in August to 7.44 million in September and is down 0.47 million from June of 2024.
- Hires is up slightly from 5.44 million in August to 5.56 million in September and increased 0.31 million over the level in June of 2024. The number of hires is the highest since May of 2024.
- September Quits level decreased to 3.07 million, the lowest since July 2020.
- The September Quits rate decreased to 1.9% compared to 2.0% in August.
- The unemployment rate in October inched down to 4.1%, after increasing to 4.3% in July.





HRM 2024 Q3 vs. 2024 Q2 Transactions

Q3'24 registered a significant decrease in M&A transactions at 91 deals compared to 120 transactions in Q2'24, down 24% sequentially.

IT Consulting and Staffing led Q3 deal activity accounting for 47% of deals, or 43 transactions. This marks a 7 deal decrease. over Q2 for the most active segment. Government IT Consulting & Staffing and Outsourcing Services are tied as the second most active segments with 14% of deals each (13 transactions each). For Government IT Consulting & Staffing this is a 9 deal decrease, while Outsourcing Services increased its deal count by 2 over Q2.


Professional Staffing held transaction volume even with Q2 volume of 7 deals total. Decreases were observed in Commercial Staffing and Management Consulting with 5 fewer deals each, followed by HR SaaS with 3 fewer deals, and Healthcare Staffing with 2 fewer deals.



HRM 2024 YTD vs. 2023 YTD Transactions

Comparing 2024 YTD transaction counts to 12 months ago, total transactions were up by 11 deals (+4.0%). In total, our universe experienced 290 transactions YTD vs. 279 transactions in 2023 YTD.

Government IT Consulting & Staffing transactions increased by 24 deals, followed by Outsourcing Services with 7 more deals, Commercial Staffing with 3 more deals, and Management Consulting with 2 additional transactions.


Decreases were observed in IT Consulting & Staffing with 20 fewer deals, Healthcare Staffing and HR SaaS each with 2 fewer deals and Professional Staffing with 1 fewer deal.







Commercial Staffing (Includes Clerical, Administrative & Light Industrial Staffing)





Historical Valuations (as of October 15 of respective year)








